Rock and Roll Hall of Fame and Museum

Greg Harris is in his tenth year as President and CEO of the Rock and Roll Hall of Fame and Museum in Cleveland, Ohio. The Museum is 27 years old, has welcomed over 13 million visitors, and has had an economic impact of over \$2.2 billion to the region. As CEO, he has

guided the organization through an era of unprecedented transformation with a focus on innovation to drive growth. Under his leadership the Museum has significantly increased attendance, revenue, fan engagement and community impact in fulfillment of their mission to "engage, teach and inspire through the power of rock and roll." He is currently leading a \$150 million expansion of the museum with a focus on experiential activities and authentic experiences.

Before joining the RRHOF, Greg spent 14 great years as a senior executive at the National Baseball Hall of Fame and Museum in Cooperstown, New York where he advanced from curating the Hall of Fame's broadcast media collection to ultimately serving as Vice President of Development. He launched and grew multiple new divisions, including establishing government affairs and development offices, led their earliest online collaborations, worked directly with inductees and created a strong national network of donors, sponsors and influencers.

Greg's passion for music stoked the shift from baseball to rock and roll. In the 1980s, he and a partner founded, owned and operated the legendary Philadelphia Record Exchange, a retail store that specializes in selling rare, used and independent records. The store mirrored and amplified his love of soul, blues, country, folk, punk and other forms of rock and roll. He also served as a road manager for a nationally touring group and played mediocre guitar in garage bands.

A native of Bucks County, Pennsylvania, Greg holds a B.A. degree in history from Temple University, an M.A. from the Cooperstown Graduate Program for History and Museum Studies.





Jason Schlender
Executive Administrator, Great Lakes Indian Fish & Wildlife
Commission
Member, Lac Courte Oreilles Band of Ojibwe

Jason Schlender (Manidoo Noodin) is executive administrator of Great Lakes Indian Fish & Wildlife Commission (GLIFWC), an intertribal natural resources management agency in the Ojibwe


Ceded Territory of the upper Great Lakes region. A Lac Courte Oreilles Band citizen, Schlender previously served as tribal administrator for the St. Croix Chippewa Indians of Wisconsin, vice chairman of the Lac Courte Oreilles Tribal Governing Board and chairman of GLIFWC's Voigt Intertribal Task Force.

Created in 1984, GLIFWC is comprised of 11 Ojibwe bands in Michigan, Wisconsin, and Minnesota. The tribes reserved off-reservation harvest rights to wildlife, fish, and wild plants on property transferred to the United States through treaties negotiated in 1836, 1837, 1842, and 1854. Collectively, the lands and waters included in the treaties are known as the Ceded Territory.

An all-seasons treaty rights practitioner, Schlender is familiar with hunting, fishing, and gathering areas across the Ceded Territory. In addition, he is passionate about the preservation of the Ojibwe language, culture, ceremonies, a proud owner of the Green Bay Packers, an enthusiastic golfer, and family man.

At University of Minnesota-Duluth, Schlender earned a master's degree in Tribal Administration and Governance. He is currently pursuing a First Nations Education doctorate degree through University of Wisconsin-Green Bay.





Lillian Kuri *President & CEO, The Cleveland Foundation*

Lillian Kuri became President & CEO of the Cleveland Foundation on August 1, 2023. The Cleveland Foundation is the nation's oldest community foundation with nearly \$3 billion in assets and more than \$130 million in annual grantmaking by the foundation and its donors.

Prior to becoming President & CEO, Lillian had served as the foundation's Executive Vice President & Chief Operating Officer since 2021, leading the development of the foundation's strategic plan and the design execution, operations and community planning for the foundation's new headquarters in MidTown.

Lillian joined the Cleveland Foundation in 2005 as a consultant for strategic initiatives and officially joined the staff in 2007 as a Program Director. In 2016, she was promoted to Vice President, Strategic Grantmaking, Arts & Urban Design.

Lillian has more than 20 years of experience as a nonprofit executive. Previously, she was the Executive Director of Cleveland Public Art and held positions as the manager for the City of Cleveland's Citywide Plan as well as project coordinator for the Graduate School of Design at Harvard University. As the Executive Director of Cleveland Public Art from 2000-2004, she was responsible for the implementation of over \$4 million in projects over her 4-year tenure.

Lillian holds a Master of Architecture in Urban Design from Harvard University, as well as a Bachelor of Architecture from Kent State University. She is a licensed architect in the state of Ohio and a Leadership in Energy and Environmental Design (LEED) accredited professional. She currently serves as Chair of the Cleveland Planning Commission.

Carmen Hardin is Bureau Director for Applied Forestry at WI DNR's Division of Forestry. Dr. Patrick Doran joined The Nature Conservancy in 2005 and currently serves as the Director of Strategy, Measures and Science for TNC's five-state Midwest Division. In this role, Patrick leads a team that demonstrates excellence in the areas of a) Strategic Planning, b) Measures, Evaluation and Learning, and c) Evidence-Based Science

and promotes a consistent approach to implementing the tenets of The Nature Conservancy's <u>Conservation by Design</u> approach. Throughout his career at TNC, Patrick has designed and implemented conservation strategies in Michigan, throughout the Great Lakes region, North American and globally, including the African Great Lakes. He takes a cross-disciplinary approach and has worked in fields that address protected areas establishment and management, sustainable forestry, sustainable agriculture, coastal management, invasive species, fisheries and aquatic connectivity restoration, urban conservation, climate change adaptation, and underlying measures of success, monitoring and information management. Additionally, he focuses on communicating about the wonders of the natural world.

Patrick earned his Ph.D. in ecology from Dartmouth College, where he studied forest bird populations at the Hubbard Brook Experimental Forest in the White Mountains of New Hampshire. Patrick also holds degrees from Indiana University (M.S./M.A.) and Villanova University (B.A.). He has published over 50 peer-reviewed papers on a wide variety of conservation topics.

In his life outside of the Conservancy, Patrick enjoys every possible minute engaged in some sort of outdoor or sporting activity with his wife Heather, and their two children Griffin and Carly. Patrick and Heather are currently engaged in an adventure to visit every county in Michigan for hiking, birding, and enjoying local foods and drinks.





Samira Malone *Director, Cleveland Trees Coalition*

Samira Malone is the Executive Director of The Cleveland Tree Coalition, a collaborative of public, private, and community stakeholders partnered with the City of Cleveland to create a healthy, vibrant, sustainable, and equitable urban forest. Samira works to raise awareness of the critical need for a robust tree canopy in Cleveland

and to generate financial support for the work of the Coalition. Her urban planner and environmental leader practice is rooted in racial and environmental restorative justice and holistic community development. Samira has her Master's degree in urban planning and development and her Bachelor's in urban and regional planning from Cleveland State University. She is also a proud graduate of the Cleveland Metropolitan School District.

In addition to her role as Executive Director, she serves as the elected chairwoman for the City of Cleveland Urban Forestry Commission (UFC). The purpose of UFC is to advise the Mayor and City Council on policies and regulations that will increase our neighborhoods' tree canopy and vibrancy. Under this scope, the UFC provides advice and strategic planning on how the City can implement best practices to maintain and grow Cleveland's tree canopy. In addition, the UFC's work involves providing recommendations on policy and plans, monitoring the implementation of City plans, soliciting grants or funding contributions, and much more.

Bryan Van Stippen
Program Director, National Indian Carbon Coalition
Member, Oneida Nation of Wisconsin

Bryan Van Stippen is Program Director for National Indian Carbon Coalition, an initiative of the Indian Land Tenure Foundation (ILTF) that provides education, training and technical assistance to American Indian tribes, Alaska Native Villages & Corporations, Native Hawaiian organizations and First Nations in Canada on the

development of carbon credit and renewable energy projects on tribal land. A member of the Oneida Nation of Wisconsin, Van Stippen previously served for seven years as Tribal Attorney for the Ho-Chunk Nation Department of Justice in Wisconsin where he was responsible for land acquisition and other land-related issues. He earned a Bachelors Degree in Business Administration and a Masters in Computer Information Systems from Tarleton State University in Texas. Van Stippen is a graduate of the University of North Dakota School of Law (J.D.); the University of Tulsa College of Law (LL.M. in American Indian and Indigenous Law); and the University of Arizona James E. Rogers College of Law (S.J.D in Indigenous Peoples Law & Policy). He lives with his wife and two children in Green Bay, Wisconsin.

Bryan is a representative on the Voluntary Carbon Market Initiative Expert Advisory Group, a Legacy Member of the Ecosystem Service Marketplace Consortium, and a representative on the Bipartisan Policy Center Farm and Forest Carbon Solutions Task Force.





Ridgway WhitePresident and Chief Executive Officer, Charles Stewart Mott

Foundation

Ridgway H. White became president of the Mott Foundation in 2015, as the Flint water crisis was still unfolding. White led the Foundation's swift approval of a \$4 million grant to help the city reconnect to the Detroit water system and begin the process of bringing clean water back to the community. He subsequently led the

charge on Mott's commitment in 2016 to provide up to \$100 million over five years to help the city recover and rise from the crisis — a commitment that was fulfilled in just over four years and subsequently exceeded. White is a vocal champion of the Foundation's support for a "onewater" approach to managing the nation's drinking water, storm water and wastewater systems. He is an ardent believer in the power of community foundations to be local leaders of positive change, both in the U.S. and around the world. He also has been the driving force behind the development of Mizzen by Mott, an app that aims to deliver outstanding content to afterschool providers nationwide at no cost to them.

As part of White's earlier program work for the Foundation, he also served as a loaned executive for the Uptown Reinvestment Corporation, a nonprofit organization focused on revitalizing Flint. Over the course of a decade, he oversaw the development of over 1 million square feet of mixed-use space, paving the way for numerous new businesses and restaurants to open. Notable projects included the creation of the Flint Health and Wellness District, a four-block area that is now home to the Flint Farmers' Market and Michigan State University College of Human Medicine. The Urban Land Institute Michigan and University of Michigan recognized the project with their Development/Redevelopment of the Year Award in 2014.

In a spirit of social entrepreneurship, White took it upon himself to build two schools that share a campus in the city of Flint. The project resulted in a new state-of-the-art home for the Michigan School for the Deaf, which is operated by the state of Michigan, and Powers Catholic High School.





Paul LaMarre IIIPort Director, Port of Monroe; President, American Great Lakes Ports
Association

Capt. Paul C. LaMarre III, is a third generation Great Lakes mariner whose lifelong freshwater legacy and industry advocacy has led to his recognition as a prominent leader across the Great Lakes-St Lawrence Seaway navigation system. Capt. LaMarre has served as the Port Director of the Port of Monroe, MI since 2012 and is directly responsible

for the Port's revival from being a dormant harbor to what is now a regarded as national example of seaport revival and redevelopment. A graduate of the California Maritime Academy, Capt. LaMarre holds a Bachelor of Science degree in Marine Transportation with minors in logistics and naval science and maintains an unlimited USCG Deck Officers License as a Master of Towing Vessels.

In 2013, Capt. LaMarre was appointed to the U.S. Department of Transportation's (USDOT) National Freight Advisory Committee by Secretary of Transportation Ray LaHood where he served as the sole representative of the Great Lakes-St. Lawrence Seaway System and State of Michigan. In 2016, Capt. LaMarre was appointed to the USDOT's Port Performance Freight statistics working group by Secretary of Transportation Anthony Foxx where he once again is the sole representative of the Great Lakes port community.

He was also appointed by Michigan Governor Rick Snyder as Chairman of the State's first Port Authority Advisory Committee which he still chairs for Governor Gretchen Whitmer. He also sits as a maritime advisor to the State of Michigan Commission for Logistics & Supply Chain Collaboration. In 2018, he was appointed to the USDOT's Marine Transportation System National Advisory Committee (MTSNAC) by Secretary of Transportation Elaine Chao and in 2021 was appointed to the U.S. Coast Guard's Great Lakes Pilotage Advisory Committee (GLPAC) by Secretary of Homeland Security Alejandro Mayorkas.

Capt. LaMarre is also the President of the American Great Lakes Ports Association, Vice President of the International Shipmasters Toledo Lodge #9, Vice Chairman of the National Museum of the Great Lakes and a Board Member of the Great Lakes Towing Co., Great Lakes Shipwreck Historical Society, Marine Historical Society of Detroit, Great Lakes Seaway Shipping Online Inc. (Boatnerd.com), and the Great Lakes Maritime Academy.

As a Great Lakes historian, Capt. LaMarre has received the Association of Great Lakes Maritime History's Annual Award for Historic Preservation and was also named the Marine Historical Society of Detroit's "Historian of the Year" in 2018 for his preservation of the S.S. Col James M. Schoonmaker Museum Ship. The vessel is the centerpiece of the National Museum of the Great Lakes which he also conceptualized and developed with the Great Lakes Historical Society.

He has also served as pilot in the United States Navy, having logged the majority of his flight hours in the F/A-18 Hornet.





Deborah DeLuca *Executive Director, Duluth Seaway Port Authority*

Deb DeLuca has been the executive director of the Duluth Seaway Port Authority since 2018, and proudly embraces its mission of bringing business to the port, economic development to the region, and advocating for maritime transportation, freight and industry. The Port Authority operates in the Port of Duluth-Superior, the largest port in the Great Lakes by tonnage, and amongst the top 20 in the nation.

She is the first woman to lead the organization in its history.

DeLuca has been involved in maritime, freight, and Great Lakes policy initiatives at the local, state and federal level in various roles including president of the Minnesota Ports Association, treasurer of the American Great Lakes Ports Association, chair of the Minnesota Freight Advisory Committee, and executive committee member of APEX, a regional economic and business development organization. She serves on the boards of the American Association of Port Authorities, Iron Mining Association of Minnesota, Green Marine and the Chamber of Marine Commerce and as an alternate Minnesota commissioner to the Great Lakes Commission. She also serves on the advisory committees for Minnesota Sea Grant, Wisconsin Sea Grant, and the University of Wisconsin-Superior Transportation, Logistics and Supply Chain Management Program.

Deb formerly served as Government and Environmental Affairs Director for the Port Authority and as a principal of DeLuca Strategies for 14 years prior to joining the Port Authority. A Wisconsin native, she holds B.S. and M.S. degrees from the University Wisconsin-Madison. She and her husband live, and raised their two children, in Duluth.





Terrence Bowles *President and CEO, St. Lawrence Seaway Management Corporation*

Terence F. Bowles was appointed President and Chief Executive Officer of the St. Lawrence Seaway Management Corporation on November 1, 2010. He is the third person to hold this position since the Management Corporation was established in 1998 to oversee the operations of the Canadian portion of the Seaway system.

From 2001 to 2010, Mr. Bowles was President and C.E.O. of the Iron Ore Company (IOC) of Canada, whose major shareholder is the international mining group Rio Tinto. IOC is the largest manufacturer of iron ore pellets in Canada, with facilities in Labrador City and Sept-Iles, and has a customer base covering North America, Europe and Asia.

Following his graduation as a Chemical Engineer from Laval University in Quebec City, Mr. Bowles joined Quebec Iron and Titanium (QIT). During his lengthy career at QIT, he assumed a series of progressively more senior assignments which culminated with his appointment as President.

Along with his Engineering Degree, he obtained a Masters in Business Administration from Montreal's McGill University, completed an Advanced Executive Program at the Kellogg Graduate School of Management in Chicago, a Strategic Leadership Program at the London Business School, and McGill's Institute of Corporate Directors Program, where he received the ICD.D designation.





David Martin *Owner, the CSL Group, Inc.*

David P. A. Martin is the President of Bromart Holdings and an owner of The CSL Group Inc. and Horizon Capital Holdings, where he also serves as co-President and Chief Executive Officer. He is a former Chair of the Board of Directors of the World Wildlife Fund (Canada) and is co-founder and General Partner of Capital for Aboriginal Prosperity and Entrepreneurship Fund (CAPE Fund).

Mr. Martin graduated from McGill University with a Joint Honours degree in Political Science and History in 1997 and completed an MBA at Cambridge University in 2000. Beyond his professional endeavours, he values his family life as husband to Laurence Duguay and proud father to Ethan, Liam, and Finn.





Brian Balridge *Director, Ohio Department of Agriculture*

Brian Baldridge was appointed the 40th Director of the Ohio Department of Agriculture by Governor Mike DeWine in February 2023.

In this position, Director Baldridge provides leadership for the agriculture industry and oversees numerous regulatory, food safety, and consumer protection programs for the great State of Ohio. Food

and agriculture is the No. 1 industry in Ohio, adding more than \$124 billion to the economy each year.

He served two terms in Ohio House of Representatives, where he represented the 90th House District, encompassing all of Adams and Scioto counties, as well as the eastern part of Brown County. During his tenure, Director Baldridge served on the House Agriculture Committee and advocated for programs supporting the agricultural industry.

Director Baldridge has strong Ohio and agricultural roots. He is the seventh generation raised on the family farm that is still operational today. Throughout the years, he participated in, and has been a vocal advocate for, the 4-H community and FFA. Additionally, he was elected to serve on the Adams Soil and Water Conservation District Board of Supervisors, where he helped to direct and plan conservation efforts within the county.

Early in life, Director Baldridge had a calling to be a first responder. During high school, he started serving his community as both a firefighter and paramedic volunteering for the Wayne Township Fire Department, and later became a career member for the Anderson Township Fire Department. In 2020, he retired from Anderson Township after 25 years of service and is still a volunteer of the Wayne Township Fire Department in Adams County.

As a life-long Southern Ohio native, Director Baldridge is no stranger to serving the public. He has served as both Adams County Commissioner and Wayne Township Trustee, prior to his service at the Ohio Statehouse.

He attended Southern State Community College and Shawnee State University.

Director Baldridge currently resides in Winchester, Ohio with his wife of 31 years, Lori. They are members of the Bethlehem Church of Christ. Together they have two grown children, one grandchild and two more on the way.





Mary Mertz *Director, Ohio Department of Natural Resources*

Mary Mertz is the Director of the Ohio Department of Natural Resources, serving since 2019 after being appointed by Governor Mike DeWine. In this role, Mertz is responsible for leading one of the state's largest and most diverse agencies which manages more than 800,000 acres of public land in the state's parks, preserves, and forests, conserves fish and wildlife species, regulates the oil, gas and

mining industries, and manages water and coastal resources.

Mertz's previous positions include First Assistant Attorney General under Mike DeWine, advisor to Ohio Governor George Voinovich, and legislative director for Congressman Bob McEwen.

A native of Riverside, Mertz holds degrees from American University and George Washington University and earned her J.D. at The Ohio State University Moritz College of Law. In her free time, she enjoys sailing, hiking, and exploring Ohio's great outdoors.





Anne M. Vogel *Director, Ohio Environmental Protection Agency*

Anne M. Vogel was appointed to be the Director of the Ohio Environmental Protection Agency (EPA) by Ohio Governor Mike DeWine in January of 2023. Prior to her appointment, Vogel served as the Policy Director for the Office of Ohio Governor Mike DeWine.

Vogel brings a wealth of knowledge and experience to the helm of the Ohio EPA. While serving as the Governor's Policy Director, Vogel was charged with implementing the vision for the major initiatives of the DeWine-Husted administration. Vogel worked on the initial creation and launch of H2Ohio, the Governor's water quality initiative that brings together the Ohio EPA, Ohio Department of Agriculture, and Ohio Department of Natural Resources to improve Ohio's water quality through the creation of wetlands, the reduction in phosphorus runoff, improving access to clean drinking water, and quality sewer systems. She was also Governor DeWine's Infrastructure Coordinator, overseeing the work of multiple state agencies receiving funds under the Infrastructure Investment and Jobs Act.

Prior to joining the DeWine-Husted administration, Vogel was Managing Director of Federal Affairs for American Electric Power Company, practiced law at Porter Wright and clerked for Judge Sargus.

Vogel received a J.D. from Capital University Law School with summa cum laude distinction. In addition, she holds an M.B.A. from The Ohio State University.

Ambassador Kirsten Hillman *Ambassador of Canada to the United States*

Kirsten Hillman has served as Canada's Ambassador to the United States of America in Washington D.C. since 2020.

The first woman to be appointed to this position, Ambassador Hillman has stewarded the bilateral relationship through two administrations and the COVID-19 pandemic, managing a wide range of bilateral and global files, advocating for Canada's interests, and advancing shared

priorities.

Through her twenty-five-year career with the Government of Canada, Ambassador Hillman has held various senior diplomatic, policy, and legal positions at home and abroad. She has played critical roles in negotiating important trade agreements for Canada, including the modernization of the North America Free Trade Agreement (NAFTA), and served as Canada's Chief Negotiator for the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP). Prior to this, Ambassador Hillman practised law at the Department of Justice in Ottawa and at a private law firm in Montréal.

Ambassador Hillman grew up in Calgary and Winnipeg and holds a Bachelor of Arts from the University of Manitoba and Bachelors of Civil Law and of Common Law from McGill University. She also holds a Doctor of Laws – honoris causa – from the Royal Military College of Canada.

Mayor Bibb was born and raised on Cleveland's southeast side in the Mt. Pleasant neighborhood. Over the past 15 years, Mayor Bibb has



He delivered more than 2,500 new and renovated neighborhood homes to the area, developed after-school and summer programs that engaged more than 10,000 students each year, helped bring a grocery store to a food desert and connected small businesses to Cleveland's arts, education and healthcare institutions. He stepped down from his role at UCI in 2021 to launch his campaign for County Executive.

Chris is past Chair of the Canalway Partners Board of Directors, and the Port of Cleveland Board of Directors. In these roles, Chris was a leader on innovative projects like the Cleveland-Europe Express container service and the newly completed Towpath Trail.
